CONDITIONS

1. A pet accepted for boarding must have been inoculated or booster injected against Distemper, Leptospirosis and Parvovirus. A certificate must be produced confirming inoculations within the last twelve months. Immunisation against Canine Cough preferred but not essential.
2. Should your pet be taken ill, as determined by the proprietor, we will contact our own veterinary surgery (Shields at Bishops Waltham, or Animed at Shedfield during OOH) unless the proprietor deems it necessary to use the owner's veterinary surgery. All fees incurred will be the responsibility of the owner. (Including a £25 vet transport fee.)
3. Should the proprietor require any details or medical records from my veterinary surgeon, I give my full permission for all information to be supplied upon request.
4. The proprietor will not be held responsible for the loss or damage of any items left in the kennels/cattery by the owner.
5. Although every care & attention is given, pets are boarded entirely at the owner's risk & without any liability on the part of the proprietor. The proprietor will not be responsible for the illness, death or loss of any pet left for boarding & will accept any elderly or ill pet at their discretion but totally at the owner's risk.
6. If your pet is left more than one week after the agreed collection date without notification from you, other arrangements will be made to remove your pet from the kennels/cattery.
7. Pets dropped off before 3pm or collected after 11am will be charged an additional day.
8. Price per boarding day includes any part of any day.
9. By signing this contract, owners who wish to board two or more dogs in a sharing kennel, or two or more cats in a sharing pod, are giving their authorisation to do so, & giving authority to separate these animals should issues arise.
